LAP works closely with our Finance Division to ensure you are paid in a timely manner. To facilitate this, we need your help and, occasionally, your patience. Please keep the following in mind when completing and submitting your Statements.

- I will reply "received" when Statements are sent in electronically. If you don't receive a response, you'll need to resend the Statements.
- Finance pays by the 20<sup>th</sup> of the month. If you want to be paid by the 20<sup>th</sup>, then you must have your statements to me no later than the 7<sup>th</sup> of the month. Any statements received after the 7<sup>th</sup> will not be processed until the following month.

- o Please wait until the 20<sup>th</sup> of the month or later before reaching out to me about payment.
- Some of the Statements are hard to read and I want to make sure you are compensated correctly! Scan them to me from a copier or by taking a picture of the Statement on your phone and sending it to me as a PDF.
  - o If Finance or I cannot read the entire Statement (e.g., too dark, blurry), then you will be asked to resubmit the Statement, which may delay you being paid.
- Statements older than 6 months will not be paid, unless you document in writing exigent
  circumstances for the late Statements. Payment of any Statements older than 6 months will be
  reviewed by me and will require final approval for payment by the State Court Administrator.
  Therefore, it's critical that Statements are turned in monthly. Not doing so creates extra work for
  all involved and may result in you not being paid. Submitting statements on time will also help us
  better manage are budget.

### Lancaster CC remote confirmations

Moving forward, payment confirmations for *all* remote hearings in Lancaster County Court will be handled by <u>Kelsey Andrews</u> and <u>William Calhoon</u>. Please be sure to include the case number, name, and date of the hearing you need the confirmation for when you reach out to them. As always, if you are doing remote hearings as part of your block, confirmations will not be needed since the Ops Team can sign for all hearings done in block time.
